- Precinct 3 City Hall, 311 Third Avenue, accommodating voters within the city limits of west of Medary Avenue and South of Sixth Street and North of 8th Street South and including rural voters in Medary and Oslo Townships in Brookings County, and Fremont and Riverview Townships in Moody County
- Precinct 4 Ascension Lutheran Church, 2030 Third Street, accommodating voters within the city limits East of Medary Avenue, South of Sixth Street, North of the railroad tracks and including rural voters in Brookings, Eureka and Sterling Townships
- Precinct 5 Bethel Baptist Church, 714 Seventeenth Avenue South, accommodating voters within the city limits East of Medary Avenue and South of the railroad tracks
- Precinct 6 United Church of Christ, 828 8th Street South, accommodating voters within the city limits West of Medary Avenue and South of 8th Street South
- Precinct 7 Aurora Little Hall, accommodating voters in Aurora City, Bushnell City, and including rural voters in Argo, Afton, Alton, Aurora and Trenton Townships.
